

# Asbestos in NHS premises, London and Scotland, 2022

## LONDON

### North Central London

#### Barnet, Enfield and Haringey Mental Health NHS Trust

Owns/uses 69 buildings, duty holder for only 1 but 47 surveyed (unnamed as could endanger individuals/negatively impact on plans/compromise safety): 44 survey dates given (2008-2020); 31 review dates; 16 public access; 5 vacant.

Total premises or buildings: 69 (response refers to buildings).  
Duty holder for: 1 (as a percentage of premises owned or used: 1.4%).  
Surveyed: 47 (44 survey dates given between 2008 and 2020 but not for identifiable premises).  
Asbestos present: 44 (as a percentage of duty holder's premises or buildings: 440%). 44 entries under 'name or title of premises with asbestos' including 5 vacant & 3 under refurbishment.  
Management plan: 44 survey dates given (2008-2020) but not for identifiable premises  
Reviewed since Jan. 2019: 31 more recent review dates given but not for identifiable premises  
Public access: indicted in 16 cases.

#### Camden and Islington NHS Foundation Trust

34 out of 35 premises that are owned or used have asbestos, 22 with public access (the Trust is duty holder for 34). The list mainly includes different parts of St Pancras Hospital plus 4 mental health facilities. Surveyed & reviewed in ...

Total premises or buildings: 35  
Duty holder for: 34 (as a percentage of premises owned or used: 97.1%). Total 35, duty holder 34 (35th premises not identified).  
Surveyed: 35  
Asbestos present: 34(as a percentage of duty holder's premises or buildings: 100.0%).

Public access: 22 (18 identified).

#### Central and North West London NHS Foundation Trust

Owns or uses 120 premises: asbestos surveyed and present in all 48 that it owns, but information N/A where NHSPS/others are responsible. There is a single management plan covering the organisation, with reviews in 2022 and review dates in 2023.

Total premises or buildings: 120 (the Trust provided a spreadsheet of 120 premises with clinical and non-clinical uses).  
Duty holder for: 48 (as a percentage of premises owned or used: 40.0%). All except NHSPS sites (the 48 are freehold sites, others listed as leasehold etc.)  
Surveyed: 48 (last survey 2022, review dates 2023).  
Asbestos present: 48 (as a percentage of duty holder's premises or buildings: 100.0%). Asbestos present in all freehold sites.  
Management plan: 48 (the Trust has a single management plan covering the organisation).  
Reviewed since Jan. 2019: 48 implied (reviewed annually during annual compliance status audits).  
Public access: All (implies 48)

#### Central London Community Healthcare NHS Trust

Owns or uses 317 premises but duty holder for 20, of which 16 health centres have been surveyed & contain asbestos. The latest surveys were in April 2022, after management reviews in January. All have public access but asbestos may not be in public areas.

Total premises or buildings: 317  
Duty holder for: 20 (as a percentage of premises owned or used: 6.3%).  
Four of the 20 sites owned by the trust contain no asbestos. Of the 317 premises, data is for the 20 for which the trust is the duty holder. In the remaining 297 premises the trust operates as a tenant - to collate that data would require an extensive search ... in a number of locations and from multiple sources.

Public access: 16

### **Great Ormond Street Hospital for Children NHS Foundation Trust**

One premises owned/used, all buildings surveyed (last in 2021) and have a management plan (last reviewed in 2021): asbestos not yet removed from 2 buildings. The premises are open to public access but at Southwood asbestos is behind a locked riser door.

Total premises or buildings: 1 (the trust uses/owns 1 premises with multiple buildings).  
Duty holder for: 1 (as a percentage of premises owned or used: 100.0%). All buildings are trust-owned.  
Surveyed: All buildings within Great Ormond Street Hospital, last survey 2021

Reviewed since Jan. 2019: All buildings within Great Ormond Street, last review 2021  
Public access: Southwood has asbestos in the mechanical raiser which is behind a lock door so there is no access to public and this is on the management plan.

### **Moorfields Eye Hospital NHS Foundation Trust**

Uses 26 premises but is duty holder, surveys & has directly identified asbestos in 3: a hospital; an outpatients' centre (public access by appointment); and an admin building. Last surveys/reviews 2021; landlords confirm management plans are in place at other premises.

Duty holder for: 3 (as a percentage of premises owned or used: 11.5%).  
Others owned by various NHS bodies including NHSPS, CHP and other trusts.  
Surveyed: 3 (three directly as MEH - Kemp House, Moorfields Eye Hospital & Moorfields Private Outpatients Centre - and 11 others).  
Asbestos present: 3 (as a percentage of duty holder's premises or buildings: 100.0%).  
Management plan: Three directly by MEH – landlord confirmation others are in place.  
Reviewed since Jan. 2019: 3 (all ACM sites (3) are reviewed annually).  
Public access: 1 (main Moorfields Eye Hospital; MPOC by appointment only, Kemp House is an administrative building and access available to staff only).

### **Royal National Orthopaedic Hospital NHS Trust**

Owns/uses 56 premises but identifies itself as duty holder for 77, all surveyed. It has 54 with asbestos found but not yet removed. It says there is "limited public access" at its specialist hospital. Its last annual building review was in May 2021.

Owns/uses 10 primary sites (mainly outpatient clinics); others are used on a sessional basis/owned by 3rd party landlords. 4 have been surveyed and all found to still have asbestos. 4 mgt. plans written/reviewed since 01/01/2019....

Total premises or buildings: 10 (the trust has 10 "primary sites" with the balance of sites used on a sessional basis)  
Duty holder for: 10 (as a percentage of premises owned or used: 100.0%). Other premises are owned by 3rd party landlords to whom this responsibility falls.  
Surveyed: 4 sites  
Asbestos present: 4 (as a percentage of duty holder's premises or buildings: 40.0%).  
All are Day Clinics mainly for outpatient psychological or gender services  
Management plan: 4  
Reviewed since Jan. 2019: 4 (the balance are due for consideration during FY 2022/23)  
Public access: 4

### **University College London Hospitals NHS Foundation Trust**

Owns/uses 32 premises but is duty holder for 19 (others being either post-2000, subject to a low risk statement after historic refurbishment, or managed by another body). 19 have asbestos, 5 with public free access. The management plan is reviewed every 6 months.

Total premises or buildings: 32  
Duty holder for: 19 (as a percentage of premises owned or used: 59.4%). Refers to 19 where it is either the sole occupier or responsible for a specific location(s) within shared premises. The other 13 are either post 2000, have a low-risk statement, or managed by another duty holder.

Where the trust occupies areas and is the duty holder for those areas but is not the main duty holder for the building, this is through leasehold (Queen Square House); otherwise another duty holder retains responsibility.  
Surveyed: 19 (annual re-inspections and project specific refurbishment surveys as required)  
Asbestos present: 19 (as a percentage of duty holder's premises or buildings: 100.0%).  
Management plan: Trust-level AMP for all buildings.  
Reviewed since Jan. 2019: Trust-wide AMP reviewed and where required updated every 6 months.  
Public access: 5 with free access.

## North East London

### **Barking, Havering and Redbridge University Hospitals NHS Trust**

15 owned/used, 3 with asbestos: King George Hospital, a clinic and an admin/store. There have been multiple surveys at King George due to capital projects (latest March 2022). Open to the public but the majority of asbestos is in controlled areas i.e. plantrooms (gaskets etc.)

Total premises or buildings: 15  
Duty holder for: 5 (as a percentage of premises owned or used: 33.3%).  
The principal reason, where the Trust is not the duty holder, is that the others are leased premises.

### **Homerton University Hospital NHS Foundation Trust**

Asbestos has been found and not yet removed at Homerton University NHS Trust; a management plan is in place and has been written or reviewed 8 times since 01/01/2019. Sites used within the community arena are managed by NHS Property Services (NHSPS).

### **Royal Marsden NHS Foundation Trust**

While operating out of 3 sites, the 2 main sites have a number of buildings, making a total of 28 (the Trust is duty holder for 26). Out of 26 surveyed, 20 have asbestos (with management plans written or reviewed since 01/01/2019), all with public access.

## North West London

### **Chelsea and Westminster Hospital NHS Foundation Trust**

The Trust (which includes West Middlesex University Hospital) provided no figures but had carried out 2 major asbestos studies in the last year, with plans in place to carry out the recommendations to remove or manage the asbestos found.

Asbestos at the trust's 2 hospitals is re-inspected annually and removed "as and when required" (e.g. disturbance from reactive or planned building works, or when found to be deteriorating).

### **London North West University Healthcare NHS Trust**

Owns or uses and is duty holder for 5 premises including 3 hospitals (all have some public access).  
Yearly re-inspections with refurbishment & demolition surveys as/when required. Other responsible parties e.g. NHS Property Services own/manage other premises.

Total premises or buildings: 5  
Duty holder for: 5 (as a percentage of premises owned or used: 100.0%).  
Premises owned/managed by other responsible parties for example NHS Property Services.  
Surveyed: 4 (survey dates in 2012 and 2015 given for the 5 premises).  
Asbestos present: 5 (as a percentage of duty holder's premises or buildings: 100.0%).  
5 sites: Northwick Park & St. Mark's Hospital; Ealing Hospital; Central Middlesex Hospital; Caryl Thomas Clinic; and Mattock Lane Health Centre.

Reviewed since Jan. 2019: Reviewed annually/re-inspections on a yearly basis/refurbishment & demolition surveys as/when required.  
Public access: All have some areas where the public may access.

### **West London NHS Trust**

Owns/uses 30 premises and is duty holder for 21. At least 10 still have asbestos, up to 5 more "TBC".  
Survey dates mainly between 2020 and 2022, with management plan reviews due in June or August 2022. Nearly all sites open to the public for treatment.

Total premises or buildings: 30 (the spreadsheet provided lists 30 premises).  
Duty holder for: 21 (as a percentage of premises owned or used: 70.0%). The spreadsheet identifies 9 premises for which it is not duty-holder.

Reviewed since Jan. 2019: All to be reviewed in June 2022  
Public access: All (only in parts in 2 cases)

## **South East & South West London**

### **South London and Maudsley NHS Foundation Trust**

Owns/uses 166 premises but is duty holder for 119 (inc. 3 post-2000, not surveyed). 59 have asbestos (all management plans reviewed since 01/01/2019). 45 have public access. In other premises someone else is responsible (e.g. a landlord or tenant).

Total premises or buildings: 166  
Duty holder for: 119 (as a percentage of premises owned or used: 71.7%). 47 premises listed where a tenant or the landlord is responsible (or a housing association, KCH or NHSPS).

## South East London

### King's College Hospital NHS Foundation Trust

The Trust has 4 campuses/23 sites, using 114 buildings of which it is duty-holder for 86: 28 have asbestos present & public access. Its overall management plan for all sites was reviewed in 2020. Other duty holders are NHS Property Services, PFI & private owners.

Total premises or buildings: 114 (4 campuses including Satellite Community Buildings, 23 sites, 114 buildings).  
Duty holder for: 86 (as a percentage of premises owned or used: 75.4%). NHS Property Services and others are duty-holder for 28 buildings.

Management plan: 1 overall management plan for all sites.

Public access: 28

### Lewisham and Greenwich NHS Trust

Owns or uses 18 premises, of which 6 have been surveyed, but duty holder to only 3, which all contain asbestos (2 of those are health centres with public access, the third a hospital mechanical plant area). All 3 had a management plan or review in 2021.

Total premises or buildings: 18  
Duty holder for: 3 (as a percentage of premises owned or used: 16.7%). The duty holder for the other premises was not identified.  
Surveyed: 6 (in 2021/2 or 2001)

### Oxleas NHS Foundation Trust

Out of 130 premises owned/used, the Trust is duty holder in 80; has surveyed 50; and found 26 still with asbestos. They include offices, health centres & hospitals. In most cases the latest surveys were between 2010-2012 but with management plans reviewed in 2022.

## South West London

### Croydon Health Services NHS Trust

Between its main and 4 satellite sites, the Trust is duty-holder to 52 premises (out of 54 owned/used). 33 have asbestos found and managed (6 removal works have taken place); 31 surveyed and reviewed since 2020, 25 with public access.

Public Access: Given as 7 but the response identifies 25 buildings and premises with asbestos that are open to public access.

### **Epsom and St Helier University Hospitals NHS Trust**

Owns/uses 89 premises, duty holder for 45. It says 17 premises have asbestos (for 2 of its 7 sites, counting buildings with & without ACMs). In each site, public access is "building yes, asbestos area no" (hence "0" public access). Management reviews in 2021.

Public access: 0 (in all listed premises the Trust says there is public access to the buildings but not to the asbestos).

### **Hounslow and Richmond Community Healthcare NHS Trust**

Duty holder to 6 of 13 premises it owns or uses (all have been surveyed and have a management plan, reviewed annually or if works in areas take place). 4 premises (1 hospital and 3 clinics) have asbestos which has not yet been removed.

### **Kingston Hospital NHS Foundation Trust**

Owns/uses 10 premises (NHS Property Services is duty holder for some). All buildings pre-2000 (10 listed) retain ACM's within the fabric in varying amounts; all have public access; all are covered by an overarching management plan & annual inspections.

Duty holder for: All except properties where NHSPS etc. are duty holder.  
Surveyed: All buildings and properties for which Kingston is duty holder have been surveyed and are annually inspected in accordance with Regulation 4, CAR2012.

### **South West London and St George's Mental Health NHS Trust**

Owns or uses 26 premises, overall duty holder in 6 (surveyed), 3 still have asbestos. All 6 have a management plan, 4 written or reviewed since 01/01/2019. At least 2 have public access.

### Ayrshire & Arran (NHS Ayrshire & Arran)

36 out of 58 premises (50 for which the Board is a duty holder) have been surveyed and have asbestos present; all have a recent management plan, all have public access. The list provided includes hospitals, clinics, health centres and a resource centre.

Owns/uses/is duty holder for 35 premises, all with asbestos (hospitals, health centres & other facilities including transport and residence, 21 with public access). Most management plans completed in 2011 (3 written or reviewed since 01/01/2019).

Surveyed: 35

### Eileanan Siar Western Isles (NHS)

Owns/uses/is duty holder for 36 premises, 15 with asbestos, 13 with public access. All have a management plan, 1 written or reviewed since 01/01/2019 (all due May 2022). The list includes 2 hospitals, 1 clinic, 1 health centre, GPs and offices.

Duty holder for: 36 (as a percentage of premises owned or used: 100.0%).  
Surveyed: 36 (listed surveys date from 2017).

### Fife (NHS Fife)

Duty holder for 48 out of 83 premises owned/used (some "let to another body"); 32 surveyed (10 sites are post-2000), 29 with asbestos (31 sites with asbestos have public access): mainly hospitals & health centres. All sites reviewed annually.

Total premises or buildings: 83  
Duty holder for: 48 (as a percentage of premises owned or used: 57.8%). NHS Fife have let to another body.  
Surveyed: 32 (thirty two NHS Fife sites have been surveyed for asbestos; there are 10 sites where no survey is required).

Management plan: All NHS Fife sites are managed through MiCAD Property Management Software.

### **Forth Valley (NHS Forth Valley)**
